
Progressive Intercultural Community Services Society (PICS)

- Our services assist new immigrants, seniors, farm workers, women, youth and children.





Delta Demographics 2011

- According to the 2011 Canadian Census, [3] the population of Delta is 99,863, a 3.3% increase from 2006.
- Delta is a fairly diverse city with many ethnic communities
 Aboriginal population mostly reside in South Delta (Tawassan & Ladner)
- Delta is located 27 kilometres (17 mi) south of Vancouver and 22 kilometres (14 mi) north of the <u>Canada–US border</u> at Peace Arch, Surrey.
- North Delta is also home to the Burns Bog, 40 square kilometres (10,000 acres) of natural wetlands that are important for wildlife.

- In April 2014 PICS began the **process of connecting sectors** that are critical to the successful integration of recent immigrants.
- Began collaboration at the community-level aiming at the successful settlement and integration of immigrant and refugee newcomers in Delta.
- Created an organizational structure which includes:
 - a Council,
 - four issued based and
 - Four strategic priorities based working groups as well as
 - an Immigrant Advisory Committee.

- PICS is the lead agency of Local Immigration Partnership program.
- The Corporation of Delta became formally involved in the DLIP program recently.
- The Corporation of Delta hired a Social Planner recently who started working towards social welfare of Delta residents.
- The new hired Social Planner is one of the prominent members of DLIP Partnership Council.
- Thence the City that is now involved directly in settlement strategy of newcomers and refugees has become very supportive and contributory.

CITY INVOLVEMENT WITH LIP PLANNING AND IMPLEMENTATION

- The DLIP program has had an important impact at the municipal level
- The City Social Planner functions on Partnership Council and its working groups and committees.
- Corporation is contributing in creating a website that will connect newcomers with a "centralized point of information.
- Staying on top of things in respect to the arrival and settlement of Syrian refugees
- Creating resources and networks

- A DLIP community forum was attended by 60 representatives
- Recommendations from the Forum were shared with Delta Council members on newcomer's needs and service gaps.
- Neighborhood Guide was produced and printed under our 'Welcoming Inclusive Program' (WCP) and being revised with a grant from another source.
- Neighbourhood Guide for Delta is being linked to the Corporation's, partners' and other settlement agencies' websites.
