We do that by working collaboratively, diversifying in every way possible, and innovating at every level.





Who/What is a Cultural Broker?


- Cultural brokering is defined as the act of **bridging, linking, or mediating between groups or persons of differing cultural backgrounds for the purpose of reducing conflict or producing change** (Jezewski, 1990).
- A cultural broker acts as a go-between, **one who advocates on behalf of another individual or group** (Jezewski & Sotnik, 2001).
- A health care intervention through which the professional increasingly uses **cultural and health science knowledge and skills to negotiate with the client and the health care system for an effective, beneficial health care plan** (Wenger, 1995).

NEWCOMER NAVIGATION & SUPPORT UNIT

Manitoba Possible's Cultural Resource Facilitators provide direct cultural interpretation and facilitation services for clients who are newcomers to Canada and who are living with disabilities. Facilitators assist new Canadians with disabilities to understand, navigate and access rehabilitative, health and social services supports in Winnipeg.
