Smaller Centre Definition

- Population below 50,000
- Outside of a census Metropolitan area
- Limited settlement services, few referral opportunities, and restricted activities due to insufficient financial resources for service provider organizations
- Experiencing challenges not experienced in a Metropolitan area (example: challenges induced by geographical barriers, and lack of consistent access to technology and connectivity)
- Significant reliance on connections within communities and inter-organizational collaboration to provide supports to clients (example: referrals to mainstream programs because of limited service for newcomers)

Rural Smaller Centre Definition

- Difficult commute to the nearest Urban Centre, exacerbated by the impacts of geography and distance.
- Limited or no access to public transportation
- Absence of places for worship or religious practice, as well as a scarcity of other cultural and religious necessities.
- Limited (or restricted) access to Provincial and Federal Services (example: no IRCC offices, no Revenue Canada offices, no local 911 services, no access to specialized medical treatments etc.).
